agreement to operate an A.G.K.A.I. school may pursue same through Plaintiff.


DD 4. ~~Derek Davis agrees to remove the words "INTERNATIONAL HEADQUARTERS" from the

location.~~ replaced with Paragraph 7. D


5. Derrick Davis will follow the responsibilities and principles of the Ric Pascetta/A.G.K.A.I.
system. All disputes arising from same shall be submitted to arbitration before the Hon.







* 6. Both parties shall be allowed to observe two ~~best~~ tests within the next year at the Atco location; each party may send one observer; Defendant will advise Plaintiff when such tests are scheduled.

7. Defendant will tape over and cover the words "International Headquarters" on the round "A.G.K.A.I." sign located at the Atco premises. Said sign will be returned by Defendant to Plaintiff within nine months of the date of this Order.
